**Action:** Notice of Proposed Assessment of Class II Civil Penalty and Notice of Opportunity for

Hearing under Sections 309(g) and 311(b)(6) of the Clean Water Act

Under Sections 309(g) and 311(b)(6) of the Clean Water Act, 33 U.S.C. §§ 1319(g) and 1321(b)(6), EPA is authorized to assess a civil penalty after providing the person subject to the penalty notice of the proposed penalty and the opportunity for a hearing, and after providing interested persons public notice of the proposed penalty and a reasonable opportunity to comment on its issuance.

In Class II proceedings under Section 309(g)(2)(B), any person who violates certain provisions of the Clean Water Act may be administratively assessed a civil penalty of up to twenty thousand six hundred twenty-eight dollars (\$20,628) per day per violation for each day during which the violation continued, up to a maximum of two hundred fifty-seven thousand eight hundred forty-eight dollars (\$257,848).

In Class II proceedings under Section 311(b)(6)(B)(ii), any person who violates certain provisions of the Clean Water Act may be administratively assessed a civil penalty of up to seventeen thousand eight hundred sixteen dollars (\$17,816) per day per violation for each day during which the violation continued, up to a maximum of two hundred twenty-two thousand six hundred ninety-five dollars (\$222,695).

Proceedings are conducted in accordance with the "Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation/Termination or Suspension of Permits," found at 40 C.F.R. Part 22 ("Part 22").

The procedures by which the public may submit written comments on a proposed penalty order or participate in a penalty proceeding are set forth in Part 22. The deadline for submitting public comment on a proposed penalty order is thirty (30) days after issuance of public notice.

Pursuant to Sections 309(g) and 311(b)(6), EPA is providing public notice of the following proposed administrative penalty assessment:

Respondents (1) failed to comply with certain requirements in the facility's permit; (2) discharged stormwater and groundwater containing pollutants without authorization; and (3) failed to prepare and fully implement a Spill Prevention Control and Countermeasure ("SPCC") Plan in accordance with the Oil Pollution Prevention regulations set forth at 40 C.F.R. Part 112.

**Proposed Penalty:** Penalty of \$131,000 plus implementation of a Pollution Prevention Supplemental Environmental Project valued at \$100,000.
