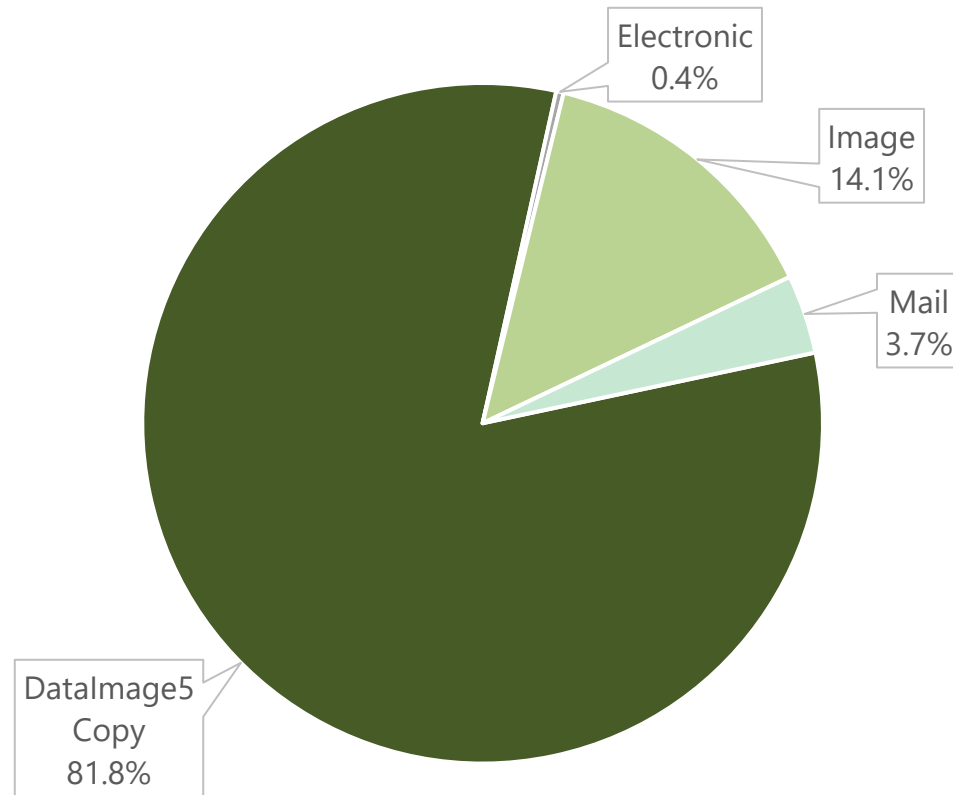

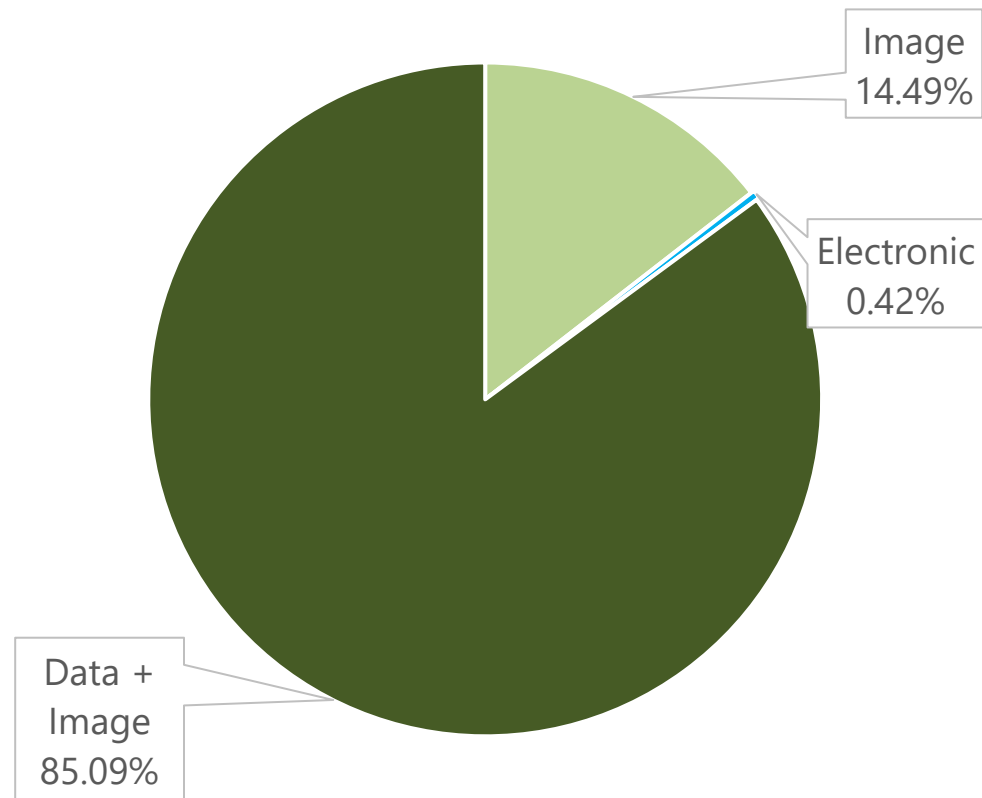
All Time Submission Summary

- Submitted manifests: 6.07 M
- Submission breakdown:
 - Data + Image: 4,967,847
 - Image Only: 855,887
 - Mail: 227,209
 - Electronic: 21,509



30-day Submission Breakdown

- Submitted manifests: 157,400
- Submission breakdown:
 - Data + Image: 133,937
 - Image Only: 22,809
 - Electronic: 652



1 Year of Quick Sign!

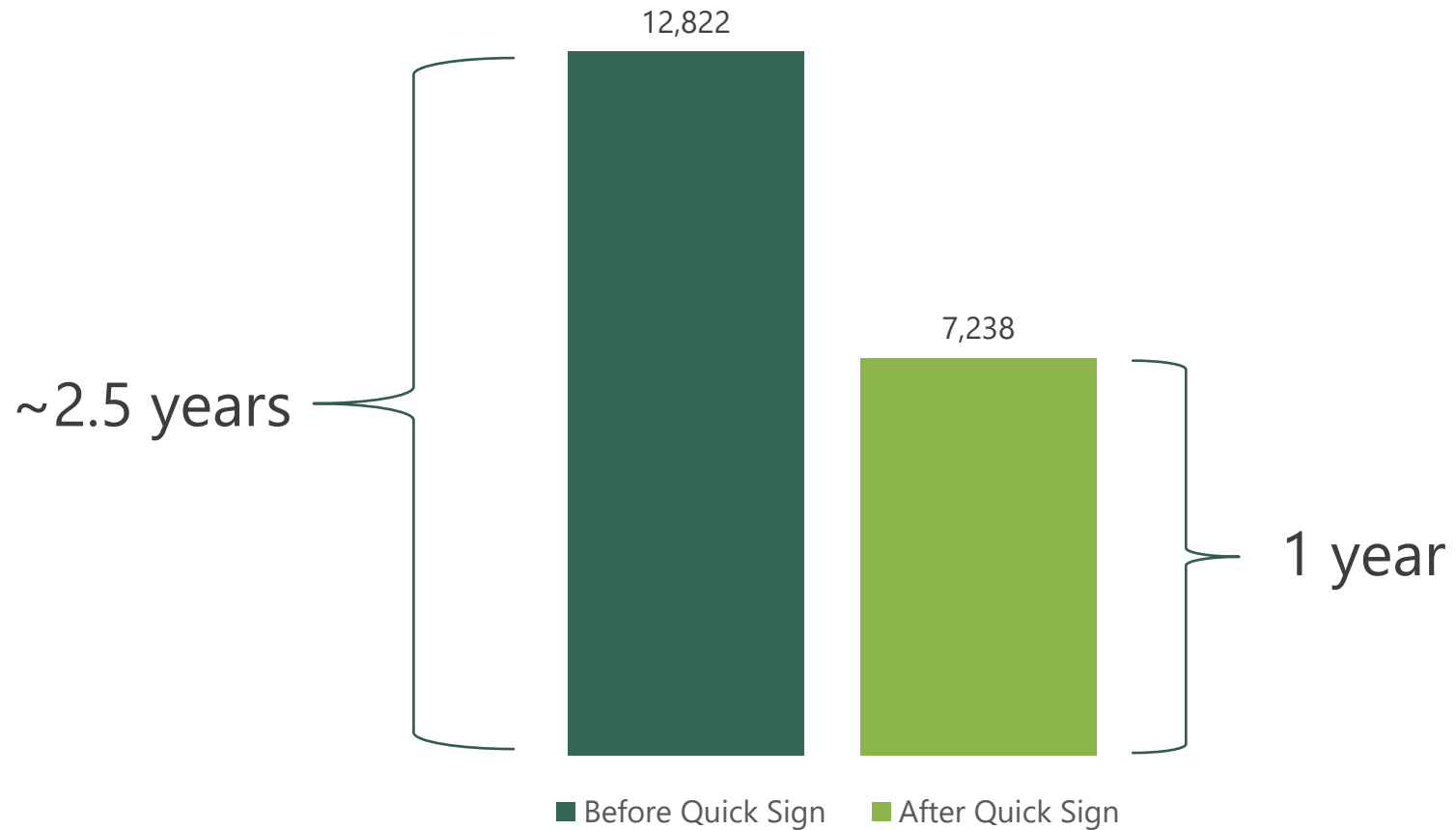
- Quick Sign went live on 12/4/20. Since then...

	Pre-Quick Sign	Post-Quick Sign
Electronic Per Day	19	25
Electronic Per Month	444	601

- Registered ~27,000 Generators with their first Site Manager
 - ↑ 50.0% increase in number of generators who registered the year before.
- Those Generators now have access to over 600,000 manifests!

1 Year of Quick Sign!

- Before quick sign:
 - 87 distinct TSDFs and 95 transporters used at least one electronic manifest
- After quick sign:
 - 15 additional TSDFs (+17%) and 31 transporters (+33%) have begun using electronic manifests
- But there is still a lot of work to be done!

e-Manifest Advisory Board Updates

- The Agency will soon publish (late December 2021) a federal register notice announcing the request for nominations for membership on the e-Manifest Advisory Board for a three-year membership term. The notice will be published in the public docket at www.regulations.gov; and announced at www.epa.gov/e-manifest and the e-Manifest listserv.

e-Manifest Public Meeting Update

- On Oct 27 and Nov 3, EPA held virtual public meetings to discuss how to increase adoption of electronic manifests. EPA is currently seeking public comment.
 - Please provide comments on or before December 30, 2021, in the public docket under docket ID number EPA-HQ-OLEM-2021-0608 by any of the following methods:
 - Federal eRulemaking Portal (our preferred method)

Upcoming Third Rule

- EPA is expecting to publish a proposed rule (“third rule”) that would propose regulatory changes to:
 - Incorporate hazardous waste export manifests and other manifest-related reports into the e-Manifest system
 - Revise the manifest form so that manifest data for import and export shipments can be recorded more clearly on them
 - Revise the export and import shipment movement document-related requirements to more closely link the manifest data with the movement document data
 - Make technical and conforming revisions, including changes related to PCB regulations under TSCA
- We expect the rule to be published for public comment in January 2022.

Generator Registration

- On December 9, 2021 (tomorrow), EPA will notify ~9,000 e-Manifest users of currently orphaned EPA Site ID numbers from their organization
- This notification...
 - Will be received via the registered user's email.
 - Will include a list of EPA Site IDs that currently do not have a registered Site Manager.
- We ask that someone from your company...
 1. Register
 2. Request access as a Site Manager (where appropriate)
 3. Review and, where necessary, correct associated data with your site ID (manifests, site details, etc.)

- Happy 1st Birthday to Quick Sign!
 - On December 4th, 2020, EPA introduced the Quick Sign feature to make it easier for transporters and generators to sign electronic manifests
 - 65% of generators are currently eligible to quick sign
 - 74% of transporters are currently eligible to quick sign
 - Want to make sure your facility is quick sign eligible?
