



Long-term Contracts

As of October 25, 2021, the combined annual green power use represented by the 446 Long-term contracts of EPA Green Power Partners amounts to nearly 36 billion kilowatt-hours of green power, which is equivalent to the annual electricity use of more than 3.3 million average American homes.
