Proposed Amendments to Two Air Toxics Standards for Oil and Natural Gas Operations FACT SHEET

Overview

- The U.S. Environmental Protection Agency has proposed amendments to two air toxics standards that apply to oil and natural gas operations: the National Emission Standards for Hazardous Air Pollutants (NESHAP) for oil and natural gas production facilities and the NESHAP for Natural Gas Transmission and Storage facilities. The proposed amendments would remove affirmative defense provisions from the rules to make them consistent with a 2014 decision from the U.S. Court of Appeals for the District of Columbia (D.C.) Circuit.
- The proposed amendments are separate from EPA's final rule to reduce emissions of methane and smog-forming volatile organic compounds (VOCs) from oil and gas operations, which the Agency announced December 2, 2023. Learn more about that rule.
- The affirmative defense provisions that the proposal seeks to amend in the two NESHAPs currently would allow owners and operators to avoid civil penalties for a violation if they provide evidence that the violation was caused by a malfunction, could not have been predicted or prevented, and was not part of a recurring pattern that indicates inadequate design, operation, or maintenance.
- In a 2014 decision, however, the U.S. Court of Appeals for the D.C. Circuit vacated the
 affirmative defense in a Clean Air Act section 112 rule establishing emission standards for
 Portland cement kilns. That led EPA to reevaluate affirmative defense provisions in Clean Air
 Act regulations.
- EPA will take comment on the proposal for 45 days after it is published in the *Federal Register*. The Agency will hold a public hearing if it receives a request within five days after publication.
- Read the proposed amendments to the NESHAPs.
